**ISSUE:** City Wide Yard Sale – Grant permission for umbrella yard sale permit for yard sale participation

**BACKGROUND SUMMARY:** The 2017 City Wide Yard Sale will be the 18<sup>th</sup> annual event. The date for this year's event is Saturday, March 4<sup>th</sup>.

This is an annual fundraiser for the Friends of the Library. Sale tables are rented at the Umatilla Library and individual yard sales are held throughout town. A book sale is also held at the Library from 8:00 a.m. through 2:00 p.m.

People holding yard sales make a contribution to have their sale put on a map published by the Friends of the Library. Copies of the map are distributed to residents and the many visitors who come to town.

The city waives the requirement for a yard sale permit for people participating in this event. Generally, yard sale permits must be applied for but there are no fees involved.

4 **A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF UMATILLA, FLORIDA,**  
5 **AUTHORIZING THE EIGHTEENTH ANNUAL CITY WIDE YARD SALE**  
6 **SPONSORED BY THE FRIENDS OF THE UMATILLA PUBLIC LIBRARY, TO BE**  
7 **HELD ON SATURDAY, MARCH 4, 2017, THROUGHOUT THE CITY OF UMATILLA**  
8 **AND IN THE UMATILLA PUBLIC LIBRARY PARKING LOT; ALLOWING WAIVER**  
9 **OF THE REQUIREMENT FOR A YARD SALE PERMIT FOR RESIDENTS OF THE**  
10 **CITY PARTICIPATING IN THIS EVENT; PROVIDING FOR AN EFFECTIVE DATE.**

11 **Whereas,** the Friends of the Umatilla Public Library are sponsoring a fundraising event to  
12 directly benefit the Umatilla Public Library; and

13 **Whereas,** this event is known as the “City Wide Yard Sale” on Saturday, March 4, 2017,  
14 throughout the City of Umatilla and in the Umatilla Public Library parking lot; and

15 **Whereas,** the Friends of the Library request a waiver of the requirement to obtain a Yard Sale  
16 permit for residents participating in this event; and

17 **Whereas,** the Friends of the Library request use of the parking lot at the Umatilla Public Library  
18 as a venue to sell food and rent tables for this event;

19 **NOW, THEREFORE, BE IT RESOLVED,** by the City Council of the City of Umatilla,  
20 Florida:

- 21 1. The City Council of the City of Umatilla grants permission to the request of the Friends  
22 of the Library to use the Umatilla Public Library parking lot during this event.  
23 2. The City Council of the City of Umatilla waives the requirement for residents  
24 participating in this event to obtain a Yard Sale permit (Ordinance 1989 – A).

26 **EFFECTIVE DATE:** This Resolution shall take effect immediately upon its adoption by the  
27 City Council of the City of Umatilla, Lake County, Florida.
